Hampshire. At the Supreme Judicial Court
begun and holden at Northampton within and
for the County of Hampshire on the third Tuesday
of September in the year of our Lord one thousand
eight hundred and five, and thence adjourned, and
now, according to said adjournment, holden at
said Northampton within and for said County
of Hampshire on the first Tuesday of December
in the year of our Lord one thousand eight
hundred and five -

The Juries for the Commonwealth of Massachusetts
do on their oath present, That Dominick Daley late
resident in Boston in the County of Suffolk Labourer
and James Halleyan late resident in Boston in the
County of Suffolk labourer, not having the fear of God
before their eyes, but being moved and seduced by the
instigation of the devil, on the ninth day of November
in the year of our Lord One thousand eight hundred and
five, with force and arms, at Wilbraham in the said
County of Hampshire, in and upon one Marcus Lyon
in the peace of God and of the said Commonwealth then and
there being, feloniously, wilfully and of their malice
aprethought, did make an assault, and that the said
Dominick Daley with a certain pistol of the value of one
dollar, which he the said Dominick Daley in his right
hand then and there had and held, him the said Marcus
Lyon, in and upon the head of him the said Marcus Lyon
then and there feloniously, wilfully and of his malice
~~aprethought~~, divers times did strike and beat, giving to him
the said Marcus Lyon, by the striking and beating of him
the said Marcus Lyon with the pistol aforesaid, in and
upon the head of him the said Marcus Lyon, divers
mortal bruises, and in and upon the back side of the
head of him the said Marcus Lyon, one mortal wound
of the depth of two inches, and of the breadth of three
inches, of which mortal bruises and wound, he the said
Marcus Lyon then and there instantly died; and that
the said James Halleyan, at the time of committing the
felony and murder aforesaid, by the said Dominick Daley

in manner and form aforesaid, feloniously, wilfully
and of his malice aforethought, was present aiding, helping,
abetting, assisting, comforting and maintaining the said
Dominick Daley, the felony and murder aforesaid, in
manner and form aforesaid, to do, commit and perpetrate;

and to the jurors aforesaid, upon their oath aforesaid, do say, That the said Dominick Daley and James Halligan him the said Marcus Lyon, then and there, in manner and form aforesaid, feloniously, wilfully and of their malice aforethought, did kill and murder, against the peace and Dignity of the said Commonwealth and then have in such case made and provided —

and the jurors aforesaid in their oath aforesaid do further present, That the said Dominick Daley & James Halligan, not having the fear of God before their eyes, but being moved and reduced by the instigation of the devil, on the said ninth day of November in the year of our Lord one thousand eight hundred and five, with fowle and arms, at Willbraham in said County of Hampshire, in and upon one Marcus Lyon, in the peace of God and of the said Commonwealth then and there being, feloniously wilfully and of their malice aforethought, did make an assault, and ^{that he} the said Dominick Daley, with a certain pistol of the value of one dollar, which he the said Dominick Daley in his right hand then and there had and held, him the said Marcus Lyon, then and there feloniously, wilfully, and of ~~the~~ his malice aforethought, divers times did strike and beat, giving to him the said Marcus Lyon, then and there by striking and beating of him the said Marcus Lyon as last aforesaid, with the pistol last aforesaid, in and upon the back side of the head of him the said Marcus Lyon, one mortal wound, of the depth of two inches and of the breadth of three inches; and that the said Dominick Daley then and there feloniously, wilfully and of his malice aforethought, did cast, throw and put him the said Marcus Lyon into a certain river called and known by the name of Chispee river then situate, wherein there was a great quantity of water, as well of which said striking and beating of him the said Marcus Lyon, in and upon the back side of the head of him the said Marcus Lyon, with the pistol last aforesaid, as also of the casting, throwing, and putting him the said Marcus Lyon, into the water aforesaid, he the said Marcus Lyon then and there instantly

died - and that the said James Hallejan, at the time
of committing the felony and murder last aforesaid,
by the said Dominick Dabey in company and fellow
last aforesaid, feloniously, wilfully and of his
malice aforethought, was present, aiding, helping

abetting, assisting, comforting and maintaining the said Dominick Daley, the felony and murder last aforesaid, in manner and form last aforesaid to do commit and perpetrate; and so the Juries aforesaid upon their oath aforesaid, do further say, that the said Dominick Daley and James Hallegan him the said Marcus Lyon then and there in manner and form last aforesaid, feloniously, wilfully, and of their malice aforethought did kill and murder, against the peace and Dignity of the said Commonwealth and their Law in such case and made and provided

do further present, That the said Dominick Daley and James Hallegan, not having the fear of God before their eyes, but being moved and reduced by the intimation of the Devil, on the ninth day of November in the year of our Lord One thousand eight hundred and five, with fownd arms, at said One thousand eight hundred and five, with fownd arms, at Willbraham in said County of Hampshire, in and upon one Marcus Lyon, in the peace of God and of the said Commonwealth then and there being feloniously, wilfully and of their malice aforethought, did make an assault, and that the said Dominick Daley, with a certain pistol of the value of one Dollar, which he the said Dominick Daley in his right hand then and there had and held, and that he the said James Hallegan with a certain other pistol of the value of one Dollar, which he the said James Hallegan in his right hand then and there had and held, then and there feloniously, wilfully and of their malice aforethought, divers times did strike and beat, giving to him the said Marcus Lyon, with the pistol last aforesaid, divers mortal bruises and wounds, one of which mortal wounds on the back side of the head of him the said Marcus Lyon, was of the depth of two inches, and of the breadth of three inches, of which said mortal bruises and wounds last aforesaid, he the said Marcus Lyon, then and there instantly died, and so the Juries aforesaid, upon their oaths aforesaid, do further say, That the said Dominick Daley and James Hallegan, him the said Marcus Lyon then and there in manner and form last aforesaid, feloniously wilfully and of their malice aforethought, did kill and murder, against the peace and Dignity of the said Commonwealth and their Law in such case made and provided -
