

COMMONWEALTH OF MASSACHUSETTS.
In the year of our Lord, one thousand seven hundred and ninety-two.

AN ACT TO INCORPORATE FUNDY. Persons by the name of the President and Directors of the UNION BANK.

(Continued from our last.)

THIRTEENTH. The Cashier, before he enters upon the duties of his office, shall give bond, with two or more sureties, to the satisfaction of the Board of Directors, in a sum not less than twenty thousand dollars, with condition for the faithful discharge of the duties of his office.

Fourteenth. All bills issued from the Bank aforesaid, and signed by the President, shall be binding on said Corporation, but it shall not be lawful for them to issue any bills of a less denomination than five dollars.

Fifteenth. The Directors shall make half yearly dividends of all the profits, rents, premiums and interests of the Bank aforesaid.

Sixteenth. The Directors shall have power to appoint a Cashier, and such other Officers and Clerks, for carrying on the business of the Bank, with such salaries and allowances as to them shall seem meet.

Seventeenth. No loans shall be made by the Directors of said Corporation, for the use, or on account of any foreign Prince or State, unless previously authorized by a law of this Commonwealth.

And be it further enacted by the authority aforesaid, That whenever the Legislature shall require it, the said Corporation shall loan to the Commonwealth, any sum of money not exceeding one hundred thousand dollars, reimbursable by five annual installments, or at a shorter period, at the election of the Commonwealth, with the annual payment of interest, at a rate, not exceeding five per centum per annum; Provided however, That the Commonwealth, shall never at any time stand indebted to said Corporation, for a larger sum than one hundred thousand dollars.

And be it further enacted by the authority aforesaid, That the principal seat of said Bank, shall be in the town of Boston, or in such other place within this Commonwealth, as the Stockholders shall direct; but the Directors may, at any future period, establish offices for the purpose of loans, discounts, and deposits, in such other towns within this Commonwealth, and commit the management thereof, to such persons, and under such regulations as to the Directors shall seem proper, and advisable.

And whereas it is repugnant to the principles of a free government, that the property of any of its citizens should be placed out of the reach of their just creditors:

Be it further enacted by the authority aforesaid, That the property of every individual member of said corporation, vested in said corporate funds, shall be liable to attachment, and to the payment and satisfaction of his just debts, to any of his bona fide creditors, in manner following, viz. In addition to the summons by law prescribed to be left with the debtor, a like summons shall be left with the Cashier of said Bank, and the debtor's shares in the said corporate funds, together with the interests, rents and profits due and growing thereon, shall hereby be held to respond said suit according to law, and all transfers of the debtor's shares, nor noted in the Bankbooks, previous to the delivery of such summons, shall be barred thereby; and execution may be levied upon the property of any Stockholder in said Bank, and his shares therein, to be exposed to sale in the same manner, as is by law provided, where personal estate is taken into execution; and it shall be the duty of the Officer who extends such execution, to leave an attested copy thereof, with his doings thereon, with the Cashier of said Bank, and the purchasers shall therupon be entitled to the reception of all dividends, and stock, and to the same privileges as a member of said Corporation, that the debtor previously was entitled to; and upon any attachment being made or execution levied on any shares in said Bank, it shall be the duty of the Cashier of said Bank, to expose the books of the Corporation to the Officer, and to

furnish him with a certificate under his hand in his official capacity, ascertaining the number of shares the debtor holds in said Bank, and the amount of the dividends thereon.

Be it further enacted by the authority aforesaid, That any Committee, specially appointed by the Legislature, for the purpose, shall have a right to examine into the doings of said Corporation, shall have free access to all their books; and if upon the report of such Committee, it shall be found, and after a full hearing of said Corporation thereon, be determined by the Legislature, that said Corporation have exceeded the powers herein granted them, or failed to comply with any of the rules, restrictions and conditions in this act provided, their incorporation shall thereupon be declared forfeited and void, and the same, shall be announced by proclamation from the Supreme Executive authority of the Commonwealth.

Fourteenth. All bills issued from the Bank aforesaid, and signed by the President, shall be binding on said Corporation, but it shall not be lawful for them to issue any bills of a less denomination than five dollars.

Fifteenth. The Directors shall make half yearly dividends of all the profits, rents, premiums and interests of the Bank aforesaid.

Sixteenth. The Directors shall have power to appoint a Cashier, and such other Officers and Clerks, for carrying on the business of the Bank, with such salaries and allowances as to them shall seem meet.

Seventeenth. No loans shall be made by the Directors of said Corporation, for the use, or on account of any foreign Prince or State, unless previously authorized by a law of this Commonwealth.

From CATHERINE PHILLIPS'S TRAVEL through

ENGLAND.

1. WILL venture to recommend, as tending to reduce the high prices of provisions, the more general use of oxen for tillage, and even drawing of carriages, rather than to many horses. So much has already been written on the subject, as to demonstrate that it would greatly to the advantage of farmers to till their land with oxen. I can see no reason for their giving the preference to horses, but that they do the work quicker; and if they would try oxen in the tractors, instead of pairing them under the yoke, perhaps that excuse would fail them. They will go faster, faster, and I think, draw a greater burthen; and on public roads this method must be far preferable to yoking them. I have seen a wagon drawn by six or more oxen in the traces, and was told, the owner of them much preferred that method to the yoke; that they were employed in carriage as well as village, and that they drew his wagon loaded, from his house to Exeter, which is full 17 miles, and returned again in a day. The public roads must be fit for oxen.

And each voter in the first and second districts, shall give in his vote for an inhabitant in each county in his district, and also another vote for an inhabitant of any part of the first, second or third district: And such voter in the third district, shall give in his vote for an inhabitant of the county of Barnsley, and shall be entitled to choose two Representatives.

The third district shall consist of the counties of Lancashire, Ribblesdale, Barnsley, Dales, County of York, and Nentwicks, and also another vote for an inhabitant in the county of Lincoln, Hereford & Worcester. And if it shall so happen, that any person shall have a majority of all the votes in the first, second and third districts, and also a majority of votes for any district or part of a district, such person shall be taken to be the Representative for the three districts, and the district in which he shall be an inhabitant, shall be called on to make another choice for such district: And if this be done, it shall be the reason for his being subjected to the choice of the first, second and third districts, as far as he has the highest number of votes in such districts.

It appears to me probable, that an improvement upon the method used for drawing with horses in traces, might be made for oxen. As much as the strength of the ox is supposed to lie in its neck, which I conclude to be the reason for its being subjected to the yoke, might not an additional collar, perhaps best made of coarse linen, where a cord or light chain might be fastened, and that again fastened to the carriage or plough, in the manner the Laplanders attach their skins to their sledges, to tend to keep down the neck of the ox, than in the usual method of drawing in traces, only. This is merely my own conjecture. I only propose it for consideration. The ox I saw draw in the traces, drew single; and I did not observe, nor hear, that their gear was any wife different from that of horses: even the tails were filled with meat, and all seemed to draw with more ease, than when whipping under the yoke. As the thing was, to me new, I took the more particular notice. But if these valuable beasts were more generally used, it might be hoped that their inhuman drivers would not be compelled in a former case.
